On 9/28/65, MM 1003-C-TE advised that SAM FRANK URBANA of Chicago and another individual, unknown to the informant, had recently arrived in the Miami area and advised VINCENT JAMES PALMISANO, Miami top hoodlum, that they were representing JACK CERONE and ROSS PRIO of Chicago and were going to "take over" Policy and Numbers in the South Florida area now under the control of HYMIE MARTIN of Miami. URBANA said that, as a front, he and his associate were purchasing a local nightclub in Miami known as the "500 Club," which establishment caters to both Negro and white clientele. U

Preliminary inquiry conducted at the 500 Club, 2724 NW 36th St., Miami, on 10/8/65, revealed that approximately two weeks prior thereto, the ownership of the club changed hands from the Brooks Management Corp. to the "SAMBO, Inc." upon the death of the owner, SAM BROOKS. A caretaker of this club identified a photo of URBANA as one of two individuals from Chicago who recently purchased this establishment. At that time, URBANA made an appearance at the club, was interviewed by a Bureau Agent, and denied that he owned any part of the 500 Club, stating that he came to Miami for the purpose of establishing permanent residence and was "looking for something legitimate" for purchase.
