CG SIX SEVEN NINE TWO DASH PC ADVISED THAT QUOTE THE SPOT ENQUOTE RESTAURANT OWNED BY JOHN CAMANALE WAS COMPLETELY DESTROYED BY FIRE WHICH OCCURRED AT THAT RESTAURANT APPROXIMATELY TEN A.M. THIS DATE. INFORMANT ADVISED THAT CHINESE CARETAKER WAS KILLED IN FIRE. INFORMANT ADVISED THAT CAMPANALE SPENT AFTERNOON BEING QUESTIONED BY COOK COUNTY SHERIFF'S POLICE CONCERNING FIRE AND DEATH OF CARETAKER. INFORMANT ADVISED IN CONTACT WITH CAMPANALE SHORTLY AFTER CAMPANALE LEARNED OF FIRE AND FROM INFORMATION RECEIVED FROM CAMPANALE FEELS CAMPANALE HAD NOTHING TO DO WITH FIRE. *u*

SERGEANT MIKE COCANATO, COOK COUNTY SHERIFF'S OFFICE, ADVISED THIS DATE THAT PRELIMINARY INVESTIGATION DID NOT INDICATE ARSON NOR WAS THERE ANY INDICATION OF FOUL PLAY INVOLVED IN DEATH OF CARETAKER. COCANATO ADVISED THAT CARETAKER HAD BEEN INSIDE RESTAURANT AT OUTSET OF FIRE, HAD LEFT AND THEN RETURNED TO INSIDE OF RESTAURANT AT WHICH TIME HE WAS OVERCOME BY SMOKE WHICH CAUSED DEATH. COCANATO ADVISED THAT INVESTIGATION IS PRESENTLY CONTINUING UNDER MAJOR INVESTIGATIVE DIVISION OF SHERIFF'S OFFICE. *u*
