Reference is made to Chicago letter to Bureau, 8/31/62 captioned, "Activities of Top Hoodlums in the Chicago Area, AR - Gambling; National Sports, AR." Reference is also made to Dallas letter to the Bureau dated 8/16/62 captioned "Criminal Intelligence Program, Dallas Division."

In view of information contained in the referenced communications, it is felt that contact with VINCENT LOMBARDI, coach, and general manager, Green Bay Packer Football Team, in the National Professional Football League, and PAUL HORNUNG of the Green Bay Packers, will be desirable.

It is felt that contact with HORNUNG may result in information pertaining to hoodlums that he reportedly has been in contact with. It is felt that contact with LOMBARDI may result in useful information and would generally have beneficial results for the Bureau. The Milwaukee Office contemplates discreetly discussing HORNUNG's activities with
