On 9/3/70, Criminal Intelligence Squad, New Scotland Yard, advised that they have been unable to develop any info concerning LOUIS LEDERER or the alleged purchase of 100 slot machines in London for use in a casino in Teheran. In this regard, it is noted that no export license is required to take slot machines out of the U.K., and no record is maintained of casual visitors arriving in England. LEDERER has not previously come to attention of New Scotland Yard either in a criminal or security capacity (U)
