HE HAS A SAFE DEPOSIT BOX AT THE BANK BUT NO ONE AT THE BANK HAS EVER BEEN PERMITTED TO SEE ITS CONTENTS. SAM ALEX DOES NOT FARM THE PROPERTY HE OWNS NEAR CASSOPOLIS AND THE ONLY ACTIVITY OBSERVED IN THIS CONNECTION WAS ABOUT TWO YEARS AGO WHEN HE WAS OBSERVED PUTTING
