PH 677-C-TE advised SA J. ROBERT PEARCE of the following on 9/23/68: U

EUNICE JOBE, a follower of Father DEVINE, who has been employed by entertainer PHYLLIS MC GUIRE of the MC GUIRE sisters for more than ten years, during the previous week visited the Father DEVINE estate in Gladwyne, Pa. While there, EUNICE discussed her employment with a mutual friend of PH 677-C-TE who in turn furnished the information indicating that PHYLLIS MC GUIRE within the next few days will terminate lease on her apartment in New York and move to Las Vegas, Nevada. MC GUIRE will reside at an unknown address which has been provided for her by "MIKE" who previously has lived with PHYLLIS MC GUIRE. MIKE is believed identical to MIKE DAVIS, as identified in Bureau radiogram to Chicago, New York, and Philadelphia 12/15/66. MIKE is described as being married to an older woman who apparently condones his affairs, is from Denver, Colorado, is wealthy, has his private airplane, and has oil wells. U

EUNICE was at the DEVINE estate as of 9/22/68, but is now believed to have returned to New York to assist PHYLLIS MC GUIRE in making her move to Las Vegas. EUNICE has an
