Copies of this report are being disseminated for the information of Denver and WFO in view of previous investigation conducted by those offices. U

LV 361-PC advised on 10/1/69 that PREACHER WELLS, Negro male American, is not an employee of the International Hotel - Las Vegas, nor has he ever been one. He advised that WELLS was formerly married to and was the manager of singer SARAH VAUGHAN and due to this association, used to spend considerable time at the Flamingo Hotel, Las Vegas. Source added that WELLS is well known to all Flamingo and International Hotel personnel and after the opening of the International, by former Flamingo hotel owners, WELLS acted as a casino messenger for various casino bosses, but was not on the payroll. He stated that WELLS overdid his authority at the International and was thereafter informed to leave. U

Source was unaware of WELLS' current activities. U
