On 1/28/63, DL-141-C, stated he understands that whenever someone replies to THOMAS' mimeographed letter indicating an interest in THOMAS' handicapping information, that THOMAS forwards the interested individual's letter on to someone in Chicago and that the interested party is then dealt with directly by the Chicago individual or organization. Informant stated he plans to send a letter to THOMAS at Post Office Box 295, Denton, Texas, expressing an interest in THOMAS' handicapping information in order to see if he is then contacted by letter from someone in Chicago.

He stated this individual called off the telephone number RI 1-4411 as he dialed the number, and that he feels sure the subscriber to this number is engaged in bookmaking.

The 1962 Criss Cross Telephone Directory for Dallas reflects telephone RI 1-4411 is listed to the Ross Avenue Drug Store at 2700 Ross Avenue, Dallas, Texas, which is known to be operated by CHARLES CLARENCE HILL, who has previously been reported to be a bookmaker.
