ABLE JOHN CHAUVIN was interviewed at New Orleans 1/16/63 at which time he admitted that he is obtaining and disseminating race wire service to bookmakers in Jefferson Parish. He advised that none of his service is going out of state, and he would be most willing to cooperate with Bureau Agents in any manner possible to determine if someone is "stealing his service" and telephoning it outside of Jefferson Parish, Louisiana.

PCI NO 1203 PC advised that he has had friends contact WOODY RUTH who has in the past furnished quick race horse results in the Chicago area, and he advised on 1/17/63 that he is out of business and not receiving race horse results. This information will be furnished to Chicago by separate communication.
