


LA FOUR TWO SIX EIGHT DASH C OBSERVED ROSELLI AT FRIAR-S CLUB, BEVERLY HILLS, CALIFORNIA AT ABOUT SIX P. M. ON AUGUST SEVEN LAST WITH MAURICE H. FRIEDMAN, RALPH MARKS AND UNKNOWN MAN WHO ACCOMPANIED MARKS. INFORMANT ESTIMATED ROSELLI HAD AT LEAST ONE THOUSAND DOLLARS IN ONE HUNDRED DOLLAR BILLS IN HIS POSSESSION.
