JOHN ROSELLI, AKA AR. LA 4396-C* ADVISED ROSELLI RETURNED TO LOS ANGELES APARTMENT LATE ON NIGHT AUGUST 29, 30 LAST BUT NO INFORMATION RECEIVED WHERE HE HAD BEEN. LA 4268-C WAS INFORMED ON AUGUST 29 LAST BY ACQUAINTANCE AT FRIAR'S CLUB THAT MAURICE H. FRIEDMAN WENT TO SAN DIEGO ON NIGHT AUGUST 28 LAST. ROSELLI WAS WITH FRIEDMAN WHEN HE LEFT.

LA 4396-C* SAID ROSELLI TALKED TO IRVING J. LEFF THIS MORNING AND TALKED ABOUT SOME MATTER, EXACT NATURE NOT KNOWN, AND ROSELLI SAID, "THEY ARE A LIVELY OUTFIT," "THEY" WANT TO "BUILD IT IN LAS VEGAS" AND "THEY" ARE GOING DOWN TO SAN JUAN. HE SAID ROCKEFELLER FOUND HIS HOTEL IN SAN JUAN COULD NOT DO WITHOUT. ROSELLI COULD BE TALKING ABOUT GAMBLING BUT SEEMS MORE LIKELY HE MAY BE REFER- RING TO SOME ENTERTAINMENT GROUP.

LA 4396-C* INDICATED LEFF WAS TO PICK ROSELLI UP AT HIS APART- MENT SHORTLY AFTER 10:00 AM TODAY. LEFF AND FRIEDMAN ARE PART- OWNERS NEW FRONTIER HOTEL, LAS VEGAS, AND FRIENDS OF ROSELLI.
