SD 1064-C-TE is expected to depart San Diego for Los Angeles on 4/9/69, where he will join Los Angeles hoodlum promoter AL GLAZER. They will fly to Buffalo, New York. LCN member LEO MOCERI of Akron, Ohio, possibly accompanied by LCN member ERNIE FUSCO, aka La Salle, will drive back to Buffalo to join them.

In Buffalo, they will contact LCN members JOE DI CARLO and SAM PIERI.

PIERI and DI CARLO will introduce them to a Buffalo contractor called PAT APOLLO.

TONY ROMANO of Daytona Beach, Florida, has been instructed to attend this meeting in Buffalo. The meeting will be held with ROMANO and APOLLO in an effort to get them to return 30,000 shares of stock that they received from GLAZER in some kind of promotional scheme.
