MUNOZ (LOPEZ) stated that he is anti-Communist and that he had information that an invasion and overthrow of the Government of the Dominican Republic was to be commanded by Colonel JULIO LOPEZ (MSSAGOZA) and CALDERON DE LA GUARDIA, former Costa Rican President who have at their command \$4,000,000 in United States money, a million of which is supposed to be under the control of LOPEZ. T-6 advised in August 1949, that ALFREDO MIRANDA is acting as a front in the purchase of planes and equipment for the LOPEZ (MSSAGOZA) group. (S)(u)
