LA 4396-C* advised ROSELLI has been at his Los Angeles apartment daily on 3/23 to 3/27/63. On 3/25/63, he was in telephonic contact with a woman who apparently had been in an automobile accident and received injuries to her face. According to LA 4396-C*, ROSELLI was to meet someone for breakfast on 3/25/63. Fisur was conducted, but ROSELLI was not located. Later that same day, according to LA 4268-C, ROSELLI was at the Friar's Club in Beverly Hills and remained there until late in the evening.

Fisur conducted on 3/26/63 revealed ROSELLI was at the Friar's Club as of approximately 4:00 p.m. He left the club shortly after 8:00 p.m., with an unknown man and went to Perino's Restaurant for dinner. He left Perino's about 11:20 p.m. At the same time, ROSELLI and his unknown companion left Perino's, a group of several men and women also left in a car, the license of which is registered to ALBERT PARVIN. It is not known if ROSELLI was with the PARVIN group in Perino's. PARVIN is the subject of an Anti-Racketeering investigation in the Los Angeles Office. He is a part owner in the Sands and the New Frontier Hotels in Las Vegas.

On 3/27/63, LA 4396-C* advised that ROSELLI stated he is leaving by car on Friday, 3/29/63. His destination was not stated, but he may be going to Las Vegas.
