LA 4268-C advised that ROSSELLI was at the Friars Club, Beverly Hills, California, on the afternoon of 6/15/64. During the period from about 3:45 p.m. until 6:30 p.m., when informant was at the club, he observed ROSSELLI in conversation in the conference room with MAURICE H. FRIEDMAN, IRVING J. LEFFXAND, and MARTY GOODMAN.

Informant said that MAURICE H. FRIEDMAN came to the club with a man about forty years of age, 6 feet tall, 240 pounds, and black bushy hair. On 6/17/64 informant said that this man was driving a maroon colored Rolls Royce with California license plate OPK-997. On 6/19/64 information was received from DMV, Los Angeles, California, that this license is registered to the Waters Holding Corporation, 122 Glendon, Westwood, Los Angeles, California.

On 6/15/64 informant learned that the young man with GOODWIN KNIGHT, former governor of California, at the Friars Club on 6/11/64, is a man named RON HOWARD. On 6/17/64 LEO KIMBERLY, a member of the Friars Club told informant that GOODWIN KNIGHT was going into the brokerage business with HOWARD and they were to be associated with some unknown New York firm.
