Date 4/16/66

RE: Movimiento Insurreccional De Recuperacion Revolucionaria (MIRR) is militant Miami, Florida, anti-Castro organization, headed by Orlando Bosch Avila. Previous information indicated MIRR was planning air attack on Cuba in near future, and Bosch had propositioned one of our informants to act as Pilot. Miami Office recommended plan whereby bombs would be seized by Customs which would thwart raid and protect our informant who is in vulnerable position. Miami's plans were discussed with the Department and Department concurred.

On 4-13-66, pursuant to Bureau instructions, SAs ROBERT J. DWYER and GEORGE E. DAVIS, JR., furnished the pertinent facts in this matter to Mr. WILLIAM A. MEADOWS, U. S. Attorney, and arrangements have been made with Mr. STANLEY SCHACHTER, U. S. Customs, to coordinate this matter with the U. S. Attorney. Mr. MEADOWS expressed appreciation for the courtesy of having been notified and said that either he or his assistant, Mr. AARON A. FOOSANER, would be available if the occasion arose where they are needed.

For the additional information of the Bureau, on 4-11-66, MM 639-S advised that on Saturday, 4-9-66, in accordance with ORLANDO BOSCH's instructions, he met with BOSCH and a young Cuban introduced only as "BOB" at 11:00 A.M., on the outskirts of Miami. BOSCH gave MM 639-S thirty dollars to rent a plane and thereafter MM 639-S and "BOB" went to Tamiami Airport where MM 639-S rented a Cessna 172 and took "BOB" on a practice bombing flight. The latter dropped 5 two-pound bags of flour at a target in the Everglades.

Cuba to take place on Sunday, 4-17-66, from Marathon. It is possible, however, that the place of departure might be changed to Naples. In either event, MM 639-S will have prior information. In the meantime, this office is maintaining close liaison with U. S. Customs, which agency will be prepared to make a seizure of BOSCH's bombs prior to the time they are loaded on the plane. Both Customs and this office are of the opinion that the security and reputation of MM 639-S would be seriously jeopardized if the seizure was made after the bombs are loaded on the plane. (u)

Miami will keep the Bureau informed of further pertinent developments.
