

IDENTITY OF INFORMANTS

Careful consideration was given to each source concealed by T symbols in this report and T symbols were utilized only where identities must be concealed. The above informants have been known to furnish reliable information in the past and have been in a position to furnish information concerning CIVELLO's activities.

ADMINISTRATIVE DATA

This case has been carried in a pending inactive status pending action on subject's appeal of conviction in USDC, SDNY and due to the subject's limited activity during 1960.

The Bureau advised on 1/26/61 that on 1/23/61 NY-3123-C\* advised a "Commission" controls organized crime in Canada and the United States, that the underworld in Canada and the United States is operated in each state by a "boss" and "underboss" who answer to this "Commission". Informant named JOE CIVELLO as boss in Texas and stated that he presently answers to MICHELINO CLEMENTE, top hoodlum, New York Division, having previously answered to ALBERT ANASTASIA before he was murdered.

The Bureau pointed out CIVELLO as one of the top powers in an important segment of the criminal element. He apparently is in a position to arbitrate underworld disputes and assist in making and enforcing a policy involving important criminal matters. In view of this, it is apparent that continuous investigation should be conducted concerning CIVELLO's contacts, associates, finances and activity.
