Re New Orleans telcall to San Antonio, 10/31/67.

NO 1242-C advised that between 1:30 and 2:00 PM, 10/30/67, he was at the Italian Import-Export Co., New Orleans, La., a business owned by ANTHONY S. CAROLLA and FRANK GAGLIANO, suspected LCN members. During this time, ANGELO PALMISANO of New Orleans, who is the brother of VINCENT JAMES PALMISANO (convicted 10/28/66, at Miami for an AR - HOBBS ACT violation); CAROLLA, GAGLIANO and four other individuals, one of whom was known as TONY (LNU) (an employee of GAGLIANO), JIMMY (LNU) and one man wearing a fancy diamond encrusted gold belt with the initials "J. P.", appeared.

Source stated that discussion among these individuals was concerning the stupidity of the "fuzz" and specifically mentioned was the suspension of Capt. ROLAND CAPPOLA, Troop I, Louisiana State Police. One individual commented that the "fuzz" really got the wrong man when they suspended CAPPOLA and everyone then laughed. Source stated that at approximately 2:00 PM a white male appeared momentarily in the doorway and took photographs of this gathering. This individual immediately departed in a late model white over blue Rambler sedan bearing what source believed to be Texas license GKD 615.
