SAM GIANCANA, AKA. AR. DAILY SUMMARY.

CG 6498-PC ADVISED THAT HE RECENTLY CONFERRED WITH TONY TISCI AND PAT MARCY CONCERNING THE CONFLICT OF INTEREST CASE CURRENTLY PENDING AGAINST TISCI. IT IS NOTED THAT CG 6576-C\* FURNISHED DETAILS CONCERNING THIS CONFERENCE WHICH OCCURRED ON OCTOBER 14 LAST. INFORMANT ADVISED THAT TISCI TOLD HIM THAT GEORGE LEIGHTON, ATTORNEY FOR TISCI AND GIANCANA, HAD RECENTLY MADE A TRIP TO WASHINGTON D.C. WHERE HE CONFERRED WITH THE CLERK OF CONGRESS CONCERNING THE CONFLICT OF INTEREST LAWS. LEIGHTON DETERMINED THAT THE LAW READS THAT NO VIOLATION OF THE STATUTE EXISTS WHEN A GOVERNMENT EMPLOYEE REPRESENTS A MEMBER OF HIS FAMILY. LEIGHTON WAS INFORMED BY THE CLERK OF CONGRESS THAT NO PRECEDENT HAS BEEN SET ONE WAY OR ANOTHER AS TO WHETHER A FATHER-IN-LAW IS A MEMBER OF A PERSON'S FAMILY SO AS TO ENABLE A GOVERNMENT EMPLOYEE TO REPRESENT A FATHER-IN-LAW WITHOUT VIOLATION OF THE STATUTE. LEIGHTON APPARENTLY ALSO CONTACTED CONGRESSMAN LIBONATI AND LEARNED THAT LIBONATI HAD BEEN INTERVIEWED IN THIS MATTER BY TWO AGENTS OF THE FBI AND HAD INFORMED THEM THAT TISCI HAD BEEN SERVED A SUBPOENA AS A WITNESS ON BEHALF OF GIANCANA. ✓

INFORMANT ADVISED THAT IT WILL NOW BE TISCI'S DEFENSE THAT HE WAS PRESENT IN COURT WITH GIANCANA ON SUBPOENA AND ✓
