ReBu Routing Slip dated 5/11/65.

The Bureau by referenced routing slip dated 5/11/65, furnished information from [a confidential source] abroad to the effect that an unidentified person connected with the Citizen's Committee of Inquiry at 156 Fifth Avenue, NYC; was planning to produce a documentary film about present-day China in cooperation with the producer and Director of "Point of Order". Arrangements were being made to seek permission from the Chinese Peoples Government for the film to be made and from the US Department of State for the persons concerned to visit China. If the State Department refused to grant permission they planned to leave nevertheless and face the consequences on their return. (S)

The source stated that the person connected with the Citizen's Committee of Inquiry was engaged in writing a book and had undertaken to defend a man charged with trying to blow up the Statue of Liberty. (S)

Inquiry at the Motion Picture Association of America on 6/28/65, reveals that EMILE DE ANTONIO was the director and one of the producers of "Point of Order". ANTONIO is the subject of NYfile 100-92714 and Bufile 100-32158.

NY 3868-S advised SA JOHN HAAG on 5/21/65, that MARK LANE who is the national chairman of the Citizen's Committee of Inquiry is writing a book and had been retained to defend ROBERT STEELE COLLIER, who was involved in a plot to blow up the Statue of Liberty.

NY 3527-S advised SA A. LEWIS BARNETT on 5/24/65, that MARK LANE is defending those people who were involved in a plot to blow up the Statue of Liberty.

The WFO is requested to contact the US Department of State and ascertain if MARK LANE and EMILE DE ANTONIO have requested permission to visit the Chinese People's Republic.

Upon receipt of this information from the US Department of State a determination will be made by the NYC as to whether this matter will be handled under instant caption or in the case entitled "MARK LANE, IS-C".
