15. Remarks:

Miami has completed the survey of the COSTELLO residence. This is a large luxurious home located in a prosperous section of North Miami. Survey revealed that most logical area for coverage would be the Florida room adjacent to the swimming pool. This installation can be accomplished only after considerable technical work involving changing of drop wire and approximately 100 feet of station wire which runs through crawl space in attic and through bedrooms. This wire will have to be painted to match current color scheme. In addition, outside station wire will also have to be replaced. A telephone 404 jack is currently located in the Florida room and will be replaced with a similar jack converted by the laboratory in a manner similar to a MATE. Consequently, this installation

will be contingent upon the Miami Office being able to successfully change the wire and the laboratory developing an altered 404 jack.

The Miami Office believes that it is probable that BRUNO will come to Miami again this season. In view of his importance in Criminal Intelligence Program, it is recommended that Bureau authorize this installation.
