NEW YORK UNDERCOVER AGENTS THROUGH NY 6774-C HAVE BEEN IN CONTACT WITH SOL KAYE, DBA TOBACCO TOWN, HALLANDALE, FLORIDA, IN AN ATTEMPT TO PURCHASE TWO STOLEN PAINTINGS AS WELL AS OTHER ART PIECES. DURING UC CONTACTS WITH KAYE, JULIUS GRIECO WAS REVEALED AS A PRINCIPAL IN THIS OPERATION. ALTHOUGH NO "BUY" WAS MADE, MIAMI WILL REMAIN ALERT AS TO POSSIBILITY OF USING UC AND INFORMANT CONTACT WITH GRIECO AS A MEANS OF OBTAINING INFORMATION REGARDING FRANK SCHWEIHS.

JACKSONVILLE AT TALLAHASSEE, FLORIDA, WILL CONTACT FLORIDA DMV RECORDS AND ATTEMPT TO OBTAIN ANY BACKGROUND INFORMATION ON ANITA VICTORIA SCHWEIHS, DOB DECEMBER 1, 1941.
