RECEIVING OFFICES SHOULD NOTE THAT JOSEPH HANSEN, DATE OF BIRTH SEPTEMBER 21, 1937, KNOWN LOS ANGELES "HIT MAN," AN ASSOCIATE OF SCHWEIHS, AND BOTH SCHWEIHS AND HANSEN WERE TOGETHER IN MAY OF 1978 AT HOLLYWOOD, FLORIDA. BOTH CONVERSED TELEPHONICALLY WITH ANTHONY SPILOTO AT LAS VEGAS FROM LARRY MACK, INC., AUTO BROKERS, MIAMI, FLORIDA, IN MAY OF 1978.

ALL OFFICES SHOULD NOTE THAT JOSEPH TEITELBAUM, A KEY WITNESS IN "UNIRAC," THE GOVERNMENT'S CASE AGAINST CORRUPT EMPLOYERS AND LCN AFFILIATED OFFICERS OF THE INTERNATIONAL LONGSHOREMEN'S ASSOCIATION, CURRENTLY RESIDES IN THE MIAMI AREA. TEITELBAUM IS TO TESTIFY IN A MAJOR RICO TRIAL SCHEDULED TO BEGIN JANUARY 29, 1979, IN MIAMI. OWING TO HIS VALUE AS A WITNESS AND A LIKELIHOOD OF AN ASSASSINATION ATTEMPT, U. S. DISTRICT JUDGE TOOK THE UNPRECEDENTED ACTION OF ORDERING THE U. S. MARSHAL SERVICE TO PROTECT TEITELBAUM AND HIS IMMEDIATE FAMILY IN PLACE SINCE OCTOBER, 1977. SINCE THAT TIME, THE FBI HAS DEVELOPED INFORMATION ABOUT POSSIBLE "HITS" ON TEITELBAUM AND HAS PROVIDED APPROPRIATE INFORMATION AND PHOTOGRAPHS DIRECTLY TO THE U. S. MARSHAL PROTECTION DETAIL.

TEITELBAUM WAS INTERVIEWED BY BUREAU AGENTS ON DECEMBER 13, 1978, AND IDENTIFIED PHOTOGRAPH OF JOSEPH HANSEN AS INDIVIDUAL WHO ASKED HIM FOR A JOB AT THE PIONEER SHIPPING WAREHOUSE ON DECEMBER 14, 1978.

THE U. S. MARSHAL PROTECTION DETAIL HAS BEEN ADVISED OF THE IDENTITIES OF HANSEN AND SCHWEIHS, AND THEY HAVE SUPPLIED ADDITIONAL MANPOWER FOR TEITELBAUM'S PROTECTION.

ALL RECEIVING OFFICES ARE REQUESTED TO IMMEDIATELY CONTACT LOGICAL INFORMANTS TO DETERMINE IF SCHWEIHS AND HANSEN HAVE POSSIBLE CONTRACT TO KILL TEITELBAUM.

LOS ANGELES IS REQUESTED TO DETERMINE IF HANSEN IS CURRENTLY IN THE LOS ANGELES AREA.
