MISCELLANEOUS INFORMATION CONCERNING

Enclosed herewith for the Bureau is a letter dated 11/27/75 received from captioned individual.

On 12/3/75, Detective Sergeant GEORGE CROOK, Metropolitan Police, New Scotland Yard, determined that Horton Hospital, Epsom, Surrey, is a mental hospital for the more difficult types of mental cases. He also ascertained from the police force in Surrey, who had contacted the hospital regarding THOMSON, that THOMSON has been in and out of mental hospitals for many years and has been diagnosed as "schizophrenic, suffering from mental delusions." THOMSON consistently writes to high officials and has in the past written to the Prime Minister of England, the Pope, etc. On one occasion THOMSON alleged that he had been trained by the Russians.

D/S CROOK further advised that a record on subject is maintained by the Criminal Records Office of the Metropolitan Police, and record indicates several minor theft charges against subject.

In view of subject's mental history, his letter is not being acknowledged.
