TERRITORE), HAS RESPONDED BY THE ATTACHED LETTER TO QUESTIONS CONCERNING RELEASE OF CERTAIN DOCUMENTS. AN INFORMAL TRANSLATION FOLLOWS: (S)

"THE ACTIVITIES OF THE DST ARE PROTECTED BY 'DEFENSE SECRECY', WHICH ENCOMPASSES EXCHANGES OF INFORMATION WITH ALLIES. (S)

"CONSEQUENTLY, WE CANNOT AUTHORIZE DIVULGENCE OF INFORMATION MENTIONED IN NOTES 1104 OF 8/31/95 AND 1107 OF 9/1/95. [THESE ARE LEGAT PARIS NOTES TO WHICH CERTAIN DOCUMENTS WERE ATTACHED, AS LISTED BELOW.] IN THESE DOCUMENTS, DST IS CITED NUMEROUS TIMES AND ONE DST OFFICIAL IS IDENTIFIED BY NAME. IN ADDITION, THE IDENTITIES OF PEOPLE WHO WERE THE SUBJECTS OF INQUIRY ARE CLEARLY IDENTIFIED. SOME OF THEM ARE STILL ACTIVE AND COULD VERY EASILY PURSUE LEGAL ACTION AGAINST DST. (S)

"UNDER THESE CONDITIONS, YOU UNDERSTAND OUR SITUATION WITHOUT ANY DIFFICULTY. HOWEVER, THE INFORMATION MENTIONED IN NOTE NO. 1100 OF 8/23/95 AND RELATIVE TO FRAUDULENT INTELLIGENCE INFORMATION, (MATTER OF STEPHANE CISOWKI) CAN BE PLACED INTO YOUR NATIONAL ARCHIVES. (S)

IN CONCLUSION, DST DOES NOT OBJECT TO RELEASE OF THE CICOWSKI-RELATED RECORDS, BUT OBJECTS TO RELEASE OF THE REST. (S)

LEGAT PARIS NOW HAS ONE REQUEST OUTSTANDING. THIS IS DIRECTED TO THE DIRECTION CENTRALE DE LA POLICE JUDICIAIRE, CONCERNING AN UNCLASSIFIED LEGAT PARIS TELETYPE DATED 3/7/88. WE HOPE TO RECEIVE A RESPONSE BY 9/29/95, THE DATE SPECIFIED IN YOUR REFERENCED FAX, AND WILL COMMUNICATE RESULTS AS SOON AS RECEIVED. (S)
