**Title:** John F. Kennedy Records Collection Act of 1992 (the Act)

**Synopsis:** Philadelphia is requested to send requested files to Headquarters/JFK Task Force as soon as possible due to an Assassination Records Reveiw Board (ARRB) letter requiring the FBI's response.

**Details:** Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKARCA) any materials considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. The JFKARCA defines how the FBI may now postpone certain information, but the originals are still sent to the NARA, to be maintained until the year 2017 when they are to be opened in full.

Therefore, the files will not be returned to your Field Office. Since the originals will be sent to the NARA, copies of the files should be made for record purposes prior to their shipment to Headquarters. All files should be received at Headquarters no later than C.O.B. 03/14/97.
