In addition to the above, the files of the Sheriff's Office, Dallas, Texas (# 49154) reflect HUNTER was arrested on June 26, 1953, for "disturbing the peace" and was released the same date after being fined in the amount of \$38. The records of the Dallas County Sheriff's Office also show HUNTER was arrested on May 13, 1954 for being delinquent in child support payments and was released on May 17, 1954, after paying a fine of \$100 and child support amounting to \$350. Further, HUNTER was fingerprinted again by the Dallas County Sheriff's Office on September 9, 1954, for "Liquor Law violation." He entered a plea of guilty to this charge on October 18, 1954 and was fined \$100 plus court costs, which fine was paid November 29, 1954.

It is also known that HUNTER was arrested by local authorities at Chandler, Oklahoma on May 24, 1954, along with one CHARLES MARVIN WEEKS (FBI #4373855) for investigation of armed robbery, at which time HUNTER had some firearms either on his person or in his possession. HUNTER pleaded guilty to a charge of carrying concealed weapons and was fined \$50. He was released on the armed robbery charge, after it was ascertained he was in the Dallas, Texas County Jail on the date (May 15, 1954) of the holdup in question.
