For the information of the Bureau, NOFIO PECORA has been previously identified as Bufile 137-10042.

The following is a summary of information provided by NO 1298-C*, during the period from 3/1/65 to 3/7/65.:

During the captioned period this informant has developed on a day to day basis the following general information concerning the activities of PECORA, his wife, FRANCES, and mother in law, Mrs. SMITH, and other individuals mentioned below:

This informant overheard during a discussion between NOFIO PECORA, and unidentified guest at the Tropical Motel, that NOFIO PECORA's wife FRANCES works for the State of Louisiana (probably a commissioned member on a State Insurance Regulatory Board), and he overheard NOFIO brag; "see that new Chevy, she FRANCES, drives? It belongs to the State." At another point in the discussion NOFIO further bragged that he had been offered \$300,000 for his property, the Tropical Motel and Trailer Court in New Orleans, but that he had turned down the offer.
