On July 20, 1961, the Liaison Agent discussed the captioned individual with Nelson Smith of Central Intelligence Agency (CIA). Smith stated that his Agency continues to be very much interested in utilizing the captioned individual's services. CIA is very much impressed with his potential but an immediate problem was encountered because [Sanchez] could not be securely placed in Cuba or in the Dominican Republic [Sanchez] himself has clearly indicated it would be unwise for him to operate in either of those countries. According to Smith, consideration is being given to placing [Sanchez] in [Mexico] or [Venezuela] at least for a period.

The Liaison Agent pointed out to Smith that his Agency allegedly had made certain financial commitments to [Sanchez] and CIA might find it advantageous to make certain [Sanchez] does not become disillusioned. Smith admitted that commitments were made and further agreed that personal contact with [Sanchez] was absolutely necessary.
