NY 4498-C-TE advised that one CHICK BERARDI, known to the NYO and Bureau, recently returned to NYC from a trip to New Orleans. Informant said that BERARDI was sent to New Orleans on underworld business, by CARMINE TRAMUNTI, Caporegima in the LUCHESE "family" of LCN.

Informant said that BERARDI was sent to see CARLOS MARCELLO, underworld boss of the New Orleans area. Informant was unable to learn the specific reason for BERARDI's trip but did learn that BERARDI saw and spoke to CARLOS MARCELLO who put him under the care of SAM DOMINO (ph) in New Orleans. Informant said he understands that DOMINO is an underworld member under CARLOS MARCELLO.

Informant said that BERARDI told him he met several police officials and an assistant Mayor through SAM DOMINO. These individuals were all reportedly on CARLOS MARCELLO's payroll. Informant also said that MARCELLO has a big gambling
