1. FOLLOWING TRANSLATION REF A: PSA67. WHILE I WAS AT HOME

OF AMCOVE-6 PREPARING WORK, I RECEIVED NEWS THAT ORLANDO DIAZ  
HAD BEEN ARRESTED IN THE STREET BY THE D.T. I. (DEPARTAMENTO TECNICO

INVESTIGACIONES). THIS WAS AT 11:00 P.M. 6 DECEMBER. AT 2:00

A.M. EARLY IN MORNING HE REENTERED MY (APPEARS WORD MISSING

SPEAKING A WORD), SEARCHING EVERYTHING, PATTERNSSES, DIRECTORIES

(OR ADDRESS BOOKS), PAPERS, BILLS, PICTURES. TAKING AWAY WITH THEM

ADDRESSES BY FAMILY OVER THERE (IN ~~FRANCE~~).

THING (INCRIMINATING IN MY HOUSE. ORLANDO AT LIBERTY

SATURDAY AT 6:00 A.M. (7 DEC 63). THEY INTERVIEWED HIM VERY

LITTLE IN REGARD TO ME. I THOUGHT I SHOULD PRESENT MYSELF AT SAID

DEPARTMENT (D.T. I.) AND SO I DID SO. PARAZ THE NUMBER TWO FOLLOWS.

2. FOLLOWING TRANSLATION REF B: SIX EIGHT. SATURDAY 7 DEC 63.

AT 10:00 A.M. THEY (D.T. I.) MADE AN OFFICIAL COMPLAINT RECORD IN

WHICH I DENOUNCED THE VIOLATION OF MY HOME. THEY SAID NO, THEY

WERE NOT AUTHORIZED TO ENTER INTO A HOUSE IN THAT MANNER. THAT

~~SECRET~~

(TYPE ENTRY) COULD ONLY BE DONE BY C-2 AND THAT I SHOULD RETURN TO MY UNIT. THEY WOULD GO AND GET THEIR CAMEL, BUT OF COURSE THEY DID NOT. THEY HAVE NO CAMEL. I DEC 9:00 P.M. COMING FROM JAMAICA TOWARDS SANAGUA, ANGOVE-2 OBSERVED 15 TRUCKS FILLED WITH TROOPS ARMED WITH RIFLES AND CAMOUFLAGED WITH TREE BRANCHES. 35 TRUCKS WERE TOWING 35 BOOK PAGE 40 (15 HOWITZERS 152 MM-M-1937). 4 JEEPS WITH MERECHAVES EQUIPMENT.

3. FOLLOWING TRANSLATION REF C-1 SIX NINE. ON 4 DEC 63 AT 5:30 P.M. WHILE AT KILOMETER 19 CARRETERA PINAR DEL RIO TOWARDS COLOMA X COLOMA ANGOVE-3 OBSERVED 25 TRUCKS PASSING BY, LOADED WITH TROOPS, COVERED WITH CAMPS AND 12 BOOK PAGE 49 (12 HOWITZERS 152 MM-M-1937), 4 MACHINE GUNS OF 50 CALIBER, 12 BOOK PAGE 43 (12 A.A. HEAVY MACHINE GUNS M-5 MM). THEY HEADED DIRECTION LA GUATANA TOWARD SOUTH NEAR LA COLOMA. ALL PERSONNEL WERE CUBAN. I RECEIVED MSGS 31 AND 32 (CAMEL TUBE NEEDED DOWN NEAR STONE, HAD TO TAKE PICK AXE ORDER GET IT OUT. SEVERAL BILLS TORN.

4. HAVE COMMENTS IN PARENTHESES. ORLANDO (OIAZ) GONZALEZ IDENTIFIED BY UFM-11102. REQUESTING DIALS/LASO/ARREST DIAZ AND HOUSE SEARCH FROM ANGOVE-1. TUBE CACHE PLACED BY ANGOVE-1 (SEE CYL NO. 31).
