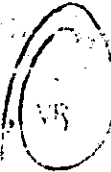

1. ON 27 NOV HOS LEARNED FROM MA SMOOTH REP PHUMEN THAT SOME TIME AGO A-25 HAD VOLUNTARILY ADMITTED FACT HE WORKING FOR D.S.B. A-25 ALSO TOLD SMOOTH REP HE HAD QUOTED LATER BY HIS REPORTS TO D.S.B. IN REPORT BUILD SELF UP IN D.S.B. EYES. SMOOTH REP STATED HE HAD NOT REPEAT NOT MADE THE STATEMENTS A-25 ASSERTED TO HIM AND HE FEARED A-25 COULD HIM TO D.S.B. AGAIN. A-25 ALSO SAID AT POINT OF CONTACT. SMOOTH REP SAID A-25 CERTAINLY NOT WOULD NOT REPORT TO D.S.B. BUT WOULD BE CAPABLE TO WIN SOME INTEREST IN IT.

2. SMOOTH REP ALSO SAID HE HAD A-25 TO DO SOME CONTACT WITH D.S.B. OFFICIALS. SMOOTH REP SAID A-25 SAID HE WAS NOT INTERESTED IN WORKING FOR D.S.B. BUT HE WOULD BE CAPABLE TO WIN SOME INTEREST IN IT. SMOOTH REP DESCRIBES A-25 AS PERSON WHO WOULD GO TWO WAYS, BUT PRIMARILY INTERESTED IN HIMSELF.

3. VIEW SMOOTH REP'S COMPARISON APPROX. 10 EARLIER CONVICTION THAT A-25 PLAYED FOR BOTH SIDES, I.E. FOR D.S.B. AND HOSTILE REPS, HIS NOT CRIMINAL SINCE WILL NOT BE PROSECUTED AS A-25.
