Organization and Functions
CONUS MILITARY INTELLIGENCE GROUP

1. (U) **PURPOSE.** This regulation prescribes the mission and delineates the command and control relationships of the US Army Intelligence and Security Command CONUS Military Intelligence Group (USAINSCOM CONUS MIGp), Fort George G. Meade, Maryland (WOOLAA).
2. (U) **MISSION.** The mission of the Commander, CONUS MI Group is to:
 - a. (U) Conduct signals intelligence (SIGINT) operations in accordance with appropriate United States Signal Intelligence Directives (USSIDs) and provide SIGINT direct service, as specified.
 - b. (U) Provide, as INSCOM's Executive Manager for the tactical SIGINT electronic warfare (EW) portion of Readiness Training (REDTRAIN), general support to the Army worldwide and general support reinforcing to Forces Command (FORSCOM), US Army Western Command (WESTCOM), and Eighth US Army (EUSA) for SIGINT by providing technical support in concert with National Security Agency/Central Security Service (NSA/CSS). Perform operational functions associated with the discharge of USAINSCOM responsibilities as DA Executive Agent for REDTRAIN.
 - c. (U) Represent the Commanding General (CG), USAINSCOM, Assistant Chief of Staff for Intelligence (ACSI)/DA, and Major Army Commands by providing continuous liaison to NSA/CSS on SIGINT policy and operational matters.
 - d. (U) Provide military manpower support to the NSA/CSS.
3. (U) **FUNCTIONS.** The functions of the USAINSCOM CONUS MIGp are to:
 - a. (U) Provide administrative, training and logistical support to assigned/attached personnel and to those assigned Army personnel supporting NSA organizations.


