

- 1 JAN 82: (U) On 1 January 1982 NAVINTCOM was three months into FY 1982 and still under continuing resolution authority (CRA) for operation and maintenance (O&M) funds. Authorized \$52,942,000 through 31 Mar 82 per message authority from CNO. First major claimant operating budget not received until 22 February 1982; allocated \$52,942,000 through the second quarter of FY 1982. The final obligational authority was \$78,912,000. NIC had an obligation rate of 99 percent. Procurement obligational authority (OPN) in Budget Activity 7, Intelligence Support Equipment, for FY 1982 totalled \$16,269,000. Obligations through December totalled \$15,146,106. The total amount of emergency and extraordinary expense funds received from SECNAV in 1982 totalled \$671,000. As of 30 September 1982, \$608,374 had been obligated.




- 30 NOV 82: (U) Command personnel represented Navy at a DIA conference on microfiche/aperture card production.

10 DEC 82: (U) Mr. John Smith of NSWC Dahlgren was named the first recipient of the CTF-168 annual Richard J. Bryce Memorial Award.

11 DEC 82: [REDACTED] Based on a NIC-03/CTF 168 COLOP message, USDAO Cairo was able to determine that the Soviet passenger ship LEONID SOBINOV was carrying 723 Cuban troops to Ethiopia. During the return Suez Canal transit, it was learned that 504 Cuban troops were being transported home. These efforts confirmed the presence of Cuban troops in Ethiopia as well as valuable troop rotation data.



30 DEC 82: (U) During 1982, 185 people were nominated for access to SCI, 205 people were indoctrinated, and 200 people were debriefed for various SCI programs. During the year the new non-disclosure agreement was executed for all personnel having access to SCI.

30 DEC 82: (U) Prepared the General Defense Intelligence Program (GDIP) POM for fiscal years 1984 through 1988. This submission was based on a completely new programming and budgeting system developed by the Director of Central Intelligence, entitled "Capabilities Programming and Budget" (CPB). CPB replaced the Zero Based Budgeting (ZBB) system used in previous years. CPB attempts to relate resources to functional capabilities for substantive intelligence targets. A major difference between ZBB and CPB is that ZBB did not require program descriptions. Under CPB, resources are looked at by function and country through use of prescribed target elements, and resources are directed toward those targets. NIC-02 personnel met with component command comptrollers and budget personnel in early February to provide detailed instruction on the new CPB concept and procedures for preparing the POM submission under it.

30 DEC 82: (U) The Navy GDIP for 1984 requested \$142.5 million in the base program, \$101.2 million in ongoing initiatives, and 48.1 million in new initiatives, for a total of \$291.8 million. It covered continued emphasis on support to the fleet, maximum effort to complete PRAIRIE WAGON, new research on support and development efforts to improve the quality of intelligence collection; support to the European, Pacific, and Atlantic theaters (in that order or priority); maintenance of useful capabilities at every existing Navy GDIP activity before pursuing new initiatives; the maintenance of S&T contributions to US weapons and systems development; and modernization and consolidation of ADP support to GDIP units in CINCLANT.

30 DEC 82: (U) The Defense Intelligence Agency recommended to the Director of Central Intelligence that the Navy GDIPP be approved at \$243.9 million. On 11 August 1982 the Secretary of Defense had advised the Navy that its GDIPP had interim approval at \$243.1 million pending program decisions to be made by the Director of Central Intelligence during the fall budget review. Following that review, the approved level of \$247.5 million was included in the President's budget which went to the Congress in January 1983.



30 DEC 82:

(U) The FY 1984 program/budget covered the entire Navy GDIP. In December 1982 COMNAVINTCOM and the DNI decided to transfer responsibility for that portion of the GDIP outside NAVINTCOM (i.e., in the fleets and unified commands) to OP-009N. Future NIC-02 actions would address only NAVINTCOM resources.
