

1. (U) Actions Taken:

a.

  
USAF intelligence inspectors also participated in an AFISC OTSI of the Tactical Air Command IG system, visiting two tactical fighter wings during the course of the inspection. The report of the Followup Inspection of Operations-Intelligence Interface was in final draft preparatory to publishing in July. A USAF intelligence inspector augmented the Air Force Intelligence Service (AFIS) inspection of USAF personnel at eight Domestic Contact Division locations. No illegalities or improprieties were noted.


b. (U) In other HQ USAF activity, two revised Air Force Regulations (AFR), AFR 95-8, Requesting and Reporting Aerial Photography, and AFR 200-19, Restrictions on Intelligence Activities, were in final edit review prior to publication.

c. (U) The AFIS IG, augmented by the USAF IG, inspected USAF administrative support to USAF personnel at eight Domestic Contact Division locations within the United States.

d. (U) The Air Force Office of Special Investigations (AFOSI) IG inspected 4 districts with a total of 20 detachments. No illegalities or improprieties were noted.


f. (U) The Electronic Security Command (ESC) IG inspected two units, finding [redacted] oversight reviews in collection and reporting, [redacted]. No illegalities or improprieties were found.

2. (U) Actions Planned:

a. (U) From 1 July through 30 September 1981, the AFISC Intelligence Inspection Branch will inspect human resources intelligence (HUMINT) activities of the Foreign Technology Division (FED) and Detachment 22, Air Force Special Activities Center (AFSAC) located at Wright-Patterson Air Force Base (AFB), Ohio. (AFSAC is the former 7602d Air Intelligence Group and other Air Force HUMINT elements.) An AFIS IG representative will accompany the USAF IG team on these inspections. The current cycle of USAF HUMINT activity inspections will be completed in early fall, 1981, with inspections of HQ AFSAC and its collocated Detachment 21 at Fort Belvoir, Virginia.

b. (U) AFIS IG will augment USAF IG inspections of AFSAC units at Wright-Patterson AFB, Ohio, and Fort Belvoir, Virginia.

c. (U) AFOSI IG will inspect 2 overseas and 2 continental United States districts with a total of 15 detachments.



e. (U) ESC IG will inspect two units and follow up a previous inspection at a third unit.
