INTELLIGENCE  
Mission and Responsibilities (U)

1. (U) Purpose. To prescribe the intelligence mission and responsibilities of USCINCEUR, theater component commanders, and other agencies within the USCINCEUR area of responsibility (AOR) during times of peace, crisis, and war.

3. (U) Explanation of Terms. N/A

4. (U) USEUCOM Intelligence Mission. The intelligence mission of USCINCEUR is to satisfy the intelligence requirements of the command and those levied on the command by the JCS, other U.S. national or intelligence community agencies, other unified and specified commands, and NATO military commands. Inherent in this mission are the provision of strategic indications and warning (I&W) to support force posturing and readiness, participation in the deliberate and crisis planning process, and support to operating forces in times of peace, crisis, and war.

5. (U) Responsibilities.

a. (U) USCINCEUR. USCINCEUR will exercise operational command over the intelligence activities of USEUCOM through the operational chain of command.

b. (U) Director of Intelligence, HQ USEUCOM. USCINCEUR has charged the Director of Intelligence with fulfilling USCINCEUR intelligence responsibilities. In general, these responsibilities fall into three categories:

(1) (U) The timely collection, processing, analysis, and dissemination of intelligence necessary for strategic I&W and the planning and conduct of USCINCEUR, SACEUR, and component, supporting, or supported commander operations.

(2) (U) The development of plans, policies, and overall requirements for command intelligence activities that are in consonance with national, DOD, and allied intelligence directives, and the guidance in reference h.

(3) (U) The initiation and direction of measures to identify and counter the action of enemy agents and supporters or terrorists who might penetrate forces of the command for the purposes of espionage, sabotage, or assassination and the detection of evidence of treason, sedition, or subversive activities.

c. (U) Specific USCINCEUR intelligence responsibilities are:

(1) (U) Maintain an I&W function within the framework of the DOD I&W System and conduct I&W surveillance, assessment, and reporting on warning problems in the Worldwide Warning Indicator Monitoring System (WWIMS) within the USEUCOM AOR.

(2) (U) Collect, analyze, produce, and disseminate intelligence required to support U.S. and allied operations and exercises in times of peace, crisis, and war.

(3) (U) Furnish to the Director, DIA, acting for the Joint Chiefs of Staff, intelligence and counterintelligence information and material originating within the USEUCOM AOR.

(4) (U) Provide intelligence support to Allied Command Europe (ACE) and to U.S. forces assigned to ACE.

(5) (U) Provide intelligence support required to plan and conduct refugee evacuation, disaster relief, and other humanitarian missions as may be directed.

(6) (U) Provide military intelligence assistance to law enforcement authorities as specified in reference g.

(7) (U) Disseminate terrorist/terrorist-related intelligence within USEUCOM

(8) (U) Provide for augmentation of command intelligence staffs by active, reserve, and allied resources to satisfy contingency and mobilization requirements.

(9) (U) Develop intelligence annexes for operational planning.

(10) (U) Develop and maintain baseline and objective intelligence architectures in response to references d and h.

(11) (U) Submit for validation to the Director, DIA, intelligence resource limitations or shortfalls critical to the accomplishment of the assigned mission.

(12) (U) Serve as the USEUCOM Requirements Control Authority to prepare, maintain, and validate theater intelligence requirements.

(13) (U) Operate the European Collection Management Office and Regional Joint Collection Management Offices to manage theater collection assets and to validate and levy command collection requirements for all-source collection by national activities.

(14) (U) Develop, maintain, and supervise plans for mapping, charting, and geodetic support.

(15) (U) Exercise staff supervision over the USEUCOM Defense Analysis Center (EUDAC).

(16) (U) Interpret and implement U.S. national disclosure policy for the release of classified U.S. military intelligence to foreign governments and international organizations.

(17) (U) Act as the Theater General Defense Intelligence Program (GDIP) Manager.

(18) (U) Operate the Joint Tactical Fusion - Limited Operational Capability Europe (JTF-LOCE) Joint Operational Support Element.

c. (U) Responsibilities common to the Component Commanders. USCINCEUR Component Commanders are responsible for fulfilling the intelligence requirements of their commands, as well as those assigned by USCINCEUR. Common responsibilities are to:

(1) (U) Maintain an I&W function within the framework of the DOD WWIMS.

(2) (U) Take the necessary counterintelligence measures to protect the command.

(3) (U) Allocate sufficient intelligence resources to support that portion of the USCINCEUR intelligence mission assigned.

(4) (U) Develop intelligence requirements and plans, conduct appropriate intelligence and counterintelligence operations, evaluate all-source information, and produce finished intelligence and materials in response to the requirements of USCINCEUR and higher headquarters.

(5) (U) Conduct appropriate U.S.-foreign government military service intelligence exchange programs, keeping HQ USEUCOM ECJ2 advised.

(6) (U) Provide intelligence support to U.S. forces assigned to ACE.

(7) (U) Keep HQ USEUCOM ECJ2 advised of:

(a) (U) Service intelligence policy or other intelligence instructions which may conflict with those of USCINCEUR.

(b) (U) Intelligence resource changes and programming proposals which impact on the intelligence mission of USCINCEUR.

(c) (U) Intelligence requirements which cannot be satisfied with assigned resources.

d. (U) CINCUSAREUR will:

(1) (U) Collect, produce, and disseminate the command's ground forces intelligence and provide quality control comments and recommendations concerning ground forces intelligence produced for USCINCEUR by external agencies.

(2) (U) Effect field coordination of U.S. military intelligence activities.

e. (U) CINCUSNAVEUR will:

(1) (U) Collect, produce, and disseminate the command's maritime intelligence and provide quality control comments and recommendations concerning naval forces intelligence produced for USCINCEUR by external agencies.

(2) (U) Coordinate with CINCLANTFLT in directing intelligence products produced by FICEURLANT.

f. (U) CINCUSAFE will collect, produce, and disseminate the command's aerospace intelligence and provide quality control comments and recommendations concerning aerospace intelligence produced for USCINCEUR by external agencies.

g. (U) Commander, EUDAC will provide all source defense analysis intelligence.

h. (U) Commander, Special Operations Command Europe (COMSOCEUR), Psychological Operations Task Force, Europe (COMPSYEUR), and Chiefs of Offices of Defense Cooperation/MAAGs/Missions and U.S. Joint Task Forces (USJTFs) will conduct intelligence activities as required and directed.
